**NOTIFICATION**

**No. F.82(265)/AD-III/Amendment PWD Act/DSW/09** - In exercise of the powers conferred by section 73 of the Persons with Disabilities (Equal opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996) read with Government of India, Ministry of Home Affairs notification no. S.O. 24 (E) dt. The 5<sup>th</sup> December, 1997, the Lt. Governor of National Capital Territory of Delhi, hereby makes the following rules to amend the Delhi Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation), Rules, 2001, namely:-

1. **Short title and commencement** - (1) These rules may be called the Delhi Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Amendment Rules, 2012.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. **Amendment of Rule 50.**- In the Delhi Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules 2001 (hereinafter referred to as the Principal Rules,) for Rule 50, the following shall be substituted, namely :-

**"50 Qualification for appointment of Commissioner.**- In order to be eligible for the appointment of Commissioner, a person must satisfy the following conditions, namely :-

- (i) He should not have attained the age of 62 years.
- (ii) If he is in a service under the Central Government or State Government, he shall seek retirement from such service before his appointment to the post.
- (iii) He must possess the following educational qualification and experience, namely :-

**I. Educational Qualification**

- (i) **Essential** : Graduate from a recognized university.
- (ii) **Desirable** : Recognized Masters degree in Social Work / Sociology.

- II. **Experience** : Should have at least 10 years of consolidated experience in one or more of the following types of organizations at specified levels -

In a Group 'A' level post in central/state govt./ public sector undertaking /semi-govt. / autonomous bodies / registered national or international level organizations dealing with disability related matters and/or social sector (Social welfare/health/ education/ poverty alleviation /women and child development).

3. **Amendment of Rule 50(A).**- In the principal rules, for rule 50(A), the following shall be substituted, namely :-

**"50 A Mode of appointment of the Commissioner.**- A Selection Committee headed by the Chief Secretary, Government of NCT of Delhi will select the Commissioner. The other members of the Committee are :-

- (i) Principal Secretary (Health & Family Welfare), Government of NCT of Delhi.
- (ii) Principal Secretary (Services), Government of NCT of Delhi.
- (iii) Secretary, Department of Social Welfare and Women and Child Development.
- (iv) Director, Department of Social Welfare, Government of NCT of Delhi (Secretary to the Committee)"

4. **Amendment of Rule 50(C).**- In the principal rules, in rule 50(C) after sub rule (2) the following shall be inserted, namely :-

"Similarly, in case senior level functionary of registered national or international level voluntary organization is appointed as full time Commissioner, the pay may be fixed in the scale of Secretary of Government of NCT of Delhi (PB -4 : Rs. 37,400-67,000 plus grade pay of Rs. 10,000/-)

The salary and other allowances shall be governed as per relevant provisions of FR and SR"

Rule-50B

- (a). In a Group 'A' level post in central/state Govt./public sector undertaking/semi-Govt. or autonomous bodies dealing with disability related matters and / or social sector (Social welfare/health/education/poverty alleviation/women and child development) ,or
- (b) A senior level functionary in a registered national or international level voluntary organization working in the field of disability/ social development, or
- (c) Senior Executive position in a leading private sector organization in social work and in charge of handling social development task in the organization:

Provided that out of the total ten years of experience mentioned above, he/she should have at least five years of experience in the field of empowerment of persons with disabilities. ] x

50(A) **Mode of appointment of the Commissioner.** - (1) <sup>one</sup> About six months before the post of the commissioner is about to vacant, an advertisement shall be published in at least two national dailies each in English and Hindi inviting application for the post from eligible candidates fulfilling the criteria mentioned in rule 50. 0 x

- (2) A search-cum- Selection Committee shall be constituted to record the panel of three suitable candidates for the post of Commissioner. ✓
- (3) Composition of the committee will be governed by relevant instructions issued by the Department of Personnel and Training from time to time. ✓
- (4) The panel recommended by the committee may consist of persons amongst those who have applied in response to the advertisement mentioned in sub-rule (1) above.
- (5) The State Government shall appoint one of the candidates recommended by search-cum-selection committee as a commissioner.

50(B). **Terms of the Commissioner.** - (1) The Commissioner shall be appointed on full-time basis for a period of three years from the date on which he/she resumes office or till he/she attain the age of 65 years, whichever is earlier.

(2) A person may serve as a Commissioner for a maximum of two terms, subject to the upper age limit of 65 years.

50(C). **Salary and allowances of the Commissioner.** - (1) The salary and the allowances of the commissioner shall be the salary and allowance as admissible to Secretary of Government of NCT of Delhi.

(2) Where a Commissioner, being a retired Government Servant or a retired employee of any institution or autonomous body funded by the Government, is in receipt of pension in respect of such previous service, the salary admissible to him under these rules shall be reduced by the amount of the pension, and if he/she had received in lieu of the portion of the pension, the commuted value thereof, by the amount of such commuted portion of the pension.

50(D). **Other terms and conditions of service of the Commissioner.** - (1) **Leave** - The Commissioner shall be entitled to such leave as is admissible to Government servants under the Central Civil Service (leave) Rules, 1972.
