Applications are invited from eligible and interested persons for appointment as Commissioner (Persons with Disabilities) as per provisions of Section 60(1) of The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 and Delhi Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 2001 read with the amendment Rules, 2011 and amendment Rules, 2012.

Qualifications, experience and other terms & conditions and the structure of emoluments have been uploaded on the Department's website at www.socialwelfare.delhigovt.nic.in. Interested persons are requested to send application in the prescribed form superscribing on the envelope "Application for the post of Commissioner (Persons with Disabilities)".

Department Social Welfare, Govt. NCT of Delhi invites application to the post of Commissioner, (Persons with Disabilities) the provision of Section 60(1) of The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 and Delhi Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 2001 read with the amendment Rules, 2011 and amendment Rules, 2012.

Qualification for appointment of Commissioner.- In order to be eligible for the appointment of Commissioner, a person must satisfy the following conditions, namely :-

- (i) He should not have attained the age of 62 years.
- (ii) If he is in a service under the Central Government or State Government, he shall seek retirement from such service before his appointment to the post.
- (iii) He must possess the following educational qualification and experience, namely :-

Educational Qualification

Essential : Graduate from a recognized university.

Desirable : Recognized Masters degree in Social Work / Sociology.

Experience : Should have at least 10 years of consolidated experience in one or more of the following types of organizations at specified levels –

“In a Group ‘A’ level post in central/state govt./ public sector undertaking /semi-govt. / autonomous bodies / registered national or international level organizations dealing with disability related matters and/or social sector (Social welfare/health/ education/ poverty alleviation /women and child development).”

Terms of the Commissioner.- (1) The Commissioner shall be appointed on full time basis for a period of three years from the date on which he/she resumes office or till he/she attain the age of 65 years, whichever is earlier.

(2) A person may serve as a Commissioner for a maximum of two terms, subject to the upper age limit of 65 years.

Salary and allowances-

- (1) The salary and the allowances of the commissioner shall be the salary and allowance as admissible to Secretary of Government of NCT of Delhi.
- (2) Where a Commissioner, being a retired Government Servant or a retired employee of any institution or autonomous body funded by the Government, is in receipt of pension in respect of such previous service, the salary admissible to him under these rules shall be reduce by the amount of the pension, and if he/she had received in lieu of the portion of the pension, the commuted value thereof, by the amount of such commuted portion of the pension. Similarly in case senior level functionary of registered national or international

level voluntary organization is appointed as full time Commissioner, the pay may be fixed in the scale of Secretary of Government of NCT of Delhi (PB -4 : Rs. 37,400-67,000 plus grade pay of Rs. 10,000/-)

The salary and other allowances shall be governed as per relevant provisions of FR and SR"

Other terms and conditions of service of the Commissioner. - (1)Leave - The Commissioner shall be entitled to such leave as is admissible to Government servants under the Central Civil Service (leave) Rules, 1972.

(2) Leave Travel Concession

The Commissioner shall be entitled to such leave travel concession as is admissible to Group 'A' Officers.

(3) Medical benefits

The Commissioner shall be entitled to such medical benefits as is admissible to Group 'A' Officers under Delhi Government Employee Health Scheme (DGEHS).

Recognition and Removal. - (1) The Commissioner may, by notice in writing, address to State Government, resign from his/her post.

- (2) The State Government shall remove a person from the office of the commissioner if he/she-
- (a) becomes undercharged insolvent,
 - (b) engages during his/her term of office in any paid employment of outside the duties of his/her office.
 - (c) Gets convicted and sentenced to imprisonment for an offence which in the opinion of State Government involves moral turpitude
 - (d) is in the opinion of the state government, unfit to continue in office, reason of infirmity of mind or body or serious default in the performance of office functions as laid down in the act,
 - (e) without obtaining leave of absence from the state of government, remain absent from duty for a consecutive period of fifteen days or more, or
 - (f) has, in the opinion of state government, so abused the position of the Commissioner as to render his continuance in office detrimental to the interest of persons with disability:

Provided that no persons shall be removed under this rule except after following the procedure, mutatis mutandis, prescribed for removal of a Group "A" employee of the Central Government

- (3). The State Government may suspend a Commissioner, in respect of whom proceedings for removal have been commenced in accordance with sub-rule (2), pending conclusion of such proceedings.

50(F). Residuary Provision. - Conditions of service of a Commissioner in respect of which no express provision has been made in these rules shall be determined by the rules and orders for the time being applicable to a Secretary to the Government of NCT of Delhi.",
