Sub:- Grant-in-Aid to Delhi brotherhood Society for running the Old Age Home at Lampur for the Senior citizens under the Scheme of Welfare Programme for Old Age Persons', Major Head "223502104710042" for the year 2011-12, 2012-13 and 2013-14

Sir,

I am directed to convey the sanction of Finance Department, GNCT of Delhi in favor of Delhi Brotherhood Society, NGO for incurring an expenditure for an amount of **Rs 31, 20, 559/- (Rupees Thirty One Lakh Twenty Thousand Five Hundred Fifty Nine only)** for the period August 2011 to sept.2012 @ 70%, September 2012 to August 2013 @ 60% and Sept'13 to March'14 @ 50% after imposing penalty of 10% on the total amount of Rs 34,67,287/- approved by the Budget and Grant-in-Aid Committee in its meeting dated 17/12/2013.


The total amount sanctioned is **Rs 31, 20, 559/- (Rupees Thirty One Lakh Twenty Thousand Five Hundred Fifty Nine only)**. The said expenditure will be debited under the Plan Scheme of welfare Programme for Old Age Persons', Major Head "223502104710042" in the Financial Year 2016-17.

1. The above recurring grant is sanctioned for the purpose of running Old Age Home located at Lampur, Delhi-40.
2. If the Govt. of NCT of Delhi is of the observation that the recurring grant sanctioned/release is not being used for the approved purpose or some amount of the same is found utilized during the current Financial year, the Govt. of NCT of Delhi can stop release of further grant and can recover all or partial amount of the recurring grant through enforcement or as land revenue.
3. The expenditure on account of release of the above referred amount of Grant-in-Aid will be debited under the Plan Scheme of welfare Programme for Old Age Persons', Major Head "2235" demand No.-8. A2(1)(3)(14) of the current Financial Year 2016-17.
4. The Organization shall follow all codal formalities as per GFR, all other provisions and instructions issued by the govt. from time to time.
5. Further the discrepancies pointed out by the department, may be taken care of by the NGO while incurring expenditure.
6. The organization shall submit a certificate that provisions of the Delhi Grants Rules are being adhered by them in their true spirit and the same are not being violated.
7. The Organization shall timely submit the Utilization Certificate to the Department.
8. The Organization shall adhere to all the provisions contained in the MOU duly signed by both the parties.


